Basic information

The Chinese Embassy is only mandated to issue limited kinds of visas for Hong Kong. You have to apply at the Immigration Office in Hong Kong to get the visa. An applicant may choose any of the below two processes:

Process 1: An applicant can submit passport copy and all the necessary documents listed below at Dragon Airlines and pay the necessary fees. They will submit your application at Hong Kong Immigration Department for visa approval. Once the visa is approved, then the immigration will send a visa sticker to the applicant. Through that visa, an applicant can fly to Hong Kong.

Process 2: An applicant gets the immigration approval through the Host Company or Tour Operators in Hong Kong. They need to apply on behalf of applicant at the Immigration Department with the fee. The processing time is at least 45 days in both processes.
